# **Committee Reports:**

Replanting in the estate has also not been carried out to satisfaction of the committee and Hacking and Paterson are currently dealing with on our behalf.

Removal of Pampas grass has now been completed

Currently communicating with the council re the repainting of the lampposts in the estate

A bin to be utilised for dog fouling has been installed at the end Moat area, all residents are asked to make us of this when walking their dogs.
